OFFERED AT SATURDAY AM & PM and SUNDAY AM SHOWS

**NOVICE CLASS** – For boys and girls at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards with competition present, in a Novice Class at a licensed or member show.

**OPEN CLASS** – For boys and girls at least 9 years old and under 18 years old on the day of the show, and who have won three (3) first place in a Novice Class at a licensed or member show, with competition present in the Novice Class.

**MASTER CLASS** - This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won the ten (10) first place wins in an Open Class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will consistent with eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their JUNIOR HANDLER NUMBER on each entry.

Grooming tables are allowed in the grooming area only. **No grooming tables are allowed at ringside.** To be sure there is room for all exhibitors **all crates MUST be stacked and have floor covering under them. BRING YOUR OWN CHAIRS.** Clean up after your dog. Failure to do so can result in an Event Committee Hearing.

**All dogs present** must be on a leash or confined to their crates except when being judged or when in an exercise pen. Place all trash in provided cans or plastic bags.

**Prizes and trophies** will be awarded in the ring to the person showing the dog. Claims for prizes and trophies must be made in the ring before the judging of that breed is over, and the show giving club disclaims any liability for prizes and trophies. None will be mailed.
